APPLICATION SUBMITTAL REQUIREMENTS

The following items, at a minimum, shall be included with the application for any General Plan amendment:

- 1) _____ A written description of the specific amendment to the General Plan text or map.
2) _____ The reason and justification for the proposed amendment and how the proposed amendment would further the purpose and intent of the Payson City General Plan.
3) _____ Supporting documentation, studies and any other information which would allow the City Council to make a well informed decision.
4) _____ The payment of the appropriate fee(s) in accordance with the Payson City fee schedule.
5) _____ Electronic copies with plans and all supporting documents in PDF format (CD or thumb drive)

APPLICATION PROCEDURE

The City Council may amend the General Plan text and/or map in accordance with the following procedure found in Section 10-9-303 and 304 of the Utah State Code:

Upon receipt by the Planning Commission of the proposed amendment, the Planning Commission shall hold a public hearing in accordance with Section 19.2.7 of the Zoning Ordinance. Following the public hearing, the Planning Commission shall forward a recommendation on the proposed amendment to the City Council.

The City Council shall hold a public hearing on the proposed amendment in accordance with Section 19.2.7 of the Zoning Ordinance. The City Council may adopt, amend and adopt, or reject the proposed amendments.
